A couple of weeks ago we had the Annual Awards evening, and I have to say it was my favourite. I felt a real buzz in the room. The community feels connected in a way I haven't experienced before. I can't quite put my finger on the reason why, but I think we're doing something special. Long may it continue.

Thank you to everyone that helped us make history this year, that gave their time to the growth of our sport, and to our Volleyball family.

Feel The Buzz, our strategic plan was launched in 2023 and focuses on growing a sustainable Volleyball community, with a vision to be recognised as a leader in inclusion, and the fastest-growing Volleyball Federation in Europe.

The highly detailed and comprehensive strategy includes 58 key results and well over 100 actions that will support, promote and grow the diverse Volleyball community in Ireland. There are 10 key performance indicators that will track Volleyball Ireland's success.

This section provides a summary update on our key performance indicators, top ten deliverables and key results.


Membership Growth

Volleyball Ireland continues on a growth trajectory with a significant increase in the number of players active within the game. This is largely due to successful participation programmes and social volley promotion, but also directly linked to an expansion of competition opportunities through the Youth League as well as the introduction of the Development League.

Some key stats:

- 63% of members were born abroad
- 53% are women
- The number of Irish born players grew 21% last season
- The number of affiliated clubs has increased by 19 to 79







Whilst the number of licensed players is growing, there is work to be done ensuring all active players are captured. It is mandatory for all social/fun players to registered by the club on JustGo.



Progress Report

Feel the Buzz has established 10 inter-linked Key Performance Indicators that are measured monthly with annual targets. These KPIs stretch across the whole organisation. This KPI scorecard uses figures from the year end, not end of season.

Three KPI targets for the end of 2026 have already been achieved. With this in mind the Board have reset targets for the Number of Affiliated Clubs, Licensed Coaches & International medals won at SCA competitions.

Following a mid-term review of Feel The Buzz, the Board have added three more key deliverables:

- Open a National Beach Volleyball Training Centre
- Agree a Memorandum of Understanding to develop an indoor National Volleyball Centre
- Review & re-design the Youth Competitions structure

Key Results

Feel The Buzz established 58 Key Results that are our 'hard' targets to achieve.

Around half of the Key Results have been achieved already, with 8 significantly exceeding targets set. 29% are on track, whilst 5 are at risk of not hitting targets. The 'at risk' key results include:

- 100 People with a disability licensing with Volleyball Ireland > work on this has started with Paralympics Ireland.
- 4 x Beach Volleyball Clubs are established > this is being piloted in 2025.
- 1,000+ supporters attend a Volleyball match in Ireland > this is unlikely by the end of 2026.



Member Survey

Now in it's sixth year the annual member's survey gives Volleyball Ireland's players, coaches and referees the opportunity to rate our performance as their Governing Body, and provides a chance to share ideas for improvement.

The 2025 version yielded low responses, with only 30 respondents (110 last year). It is important to note we published a strategy review survey earlier in the year with similar questions.



The single biggest project ever delivered by Volleyball Ireland took place in August 2024, when the u20 Women's European Championships came to Dublin.

The event was several years in the planning, and with a budget of €400k provided both organisational risk and opportunity to grow the Sport.

Key Points

- Due to a unique partnership with Fab Little Bag, the tournament was the world's first Period Supportive Volleyball event.
- Key sustainability considerations were built into the programme, such as disposable water bottles, were a first for European Volleyball.
- 112 Mikasa match balls were given to VLY clubs in lieu of Ball Crew support provided
- The event was delivered ahead of budget.
- A €32,500 Volleyball floor was donated by FIVB/CEV for hosting the event, which has had a positive impact on other VLY events.
- The CEV Supervisor provided a glowing report on Ireland's hosting of the event.

School Aged Children

Season 2024-25 witnessed an expansion of U16 Boy & Girl leagues to now include U18 Premier and Division 1 Girls as well as U18 Premier Boys. The addition of U18 to U16 now provides a clear pathway for youth to compete from U14 Blitzes and remain within leagues until adulthood.

School Volley continues to grow and innovate. New programmes like Smash Volley have been presenting even younger kids with opportunities to fall in love with volleyball earlier.

Talent Pathway Players

Ambitious plans for the pathway were to push both numbers and training regularity.

With the aim of equiping athletes better for youth national teams, the Regional Development Centre's increased from 2 to 4 centres. Seeing an increase from 74 to 89 athletes. However, trainings increased from 5 sessions to 20 sessions. With a focus split between S&C and ball training.

In addition to National Team weekends, Youth National Team players received 14 mid-week training sessions focusing on individual improvement, technical skills and S&C education.

The curtain came down on a hugely successful National League competition for 2024/25. With the reintroduction of play-offs in a number of divisions, a new play-off weekend proved a successful concept, with the winners advancing to the end of season Grand Finals.

The introduction of e-scoring in the top three divisions was massively beneficial in further automating the reporting of the game to a wider audience.

A new Division 3 Regional League drew together teams from across the country, culminating in the best eight teams playing off for glory.

Moving the Cup Finals to Limerick was beneficial in promoting the sport outside Dublin.

Beach Tour Players

The 2024 summer weather played ball and allowed for a full programme of beach tour events to take place across the country, including a new event at Inchydoney.

A new cohort of referees also joined the tour, and new Cup and Shield formats ensured that every team on the day found their level and played against similarly skilled teams.

As we now look ahead to 2025 and build on the successes of last year, the new Beach Facility at Blanchardstown will allow a significant uplift in our competition offerings, with something for everyone to enjoy.

Social & Recreational

Social volleyball memberships continue to increase at a rapid rate. We have recorded a 91.4% jump in registrations over the past 24 months as current licence numbers now exceed 1500.

New Play Volley club summer events were developed for recreational activity and club fundraising opportunities

The VLY. Annual Masters tournament saw a return to play for the first time since the Covid 19 pandemic. The event holds as an important place within our strategic objectives, as we strive to provide Volleyball for Life opportunities.

Coaches & Teachers

Strategic targets for 2026 have already been exceeded as coach licences increased 94.8% over a two-year period.

Volleyball Ireland was successful in applications to host 2 x FIVB international courses in 2025.

We have continued to focus resources that will help raise awareness and provide knowledge for youths in school and university settings. Over 1000 students took part in educational courses this academic year.

Referees & Officials

A new preseason Referee Workshop was rolled out prior to the 2024/25 season. This annual workshop provided clarity on new rule changes or uncertainties ahead of each season.

A new Referee Pathway was developed with clear guidance on how to obtain a status at each level. The pathway goal is to create quality referees through a fair and transparent system, with continuous practice a key theme.

Aurelien Gimenez was first Referee in the Men's u22 Beach Volleyball European Championship Final and achieved sign off on his International status.

Giordano Dos Santos became the first Irish referee to officiate at a European Championship Finals.

University & Third Level

Volleyball Ireland partnered with Student Sport Ireland (SSI) to enhance the competition playing opportunities and experience for both participation and performance players.

The SSI Cup finals were added to the VLY's Final Weekend programme. VLY provided competition software and support for intervarsity event in Carlow aiding to elevate experiences once again..

Our third level Energisers Programme was boosted with a final event day in Dublin and in a bid to support our beach players, we took the lead on organisation of the Beach Varsities to launch the new inland courts.

Finally, an information booklet was released providing guidance for young volleyballers around scholarships available in Ireland.

People With a Disability

Volleyball Ireland staff have met with Paralympics Ireland to begin the process of becoming an affiliated member and to develop an action plan on sitting volleyball programmes in Ireland.

Our work with the Irish Special Schools Sports Council continues to be a focus each year as we introduce indoor and beach volleyball annually to children with Intellectual disabilities.

Additional funding was secured from Sport Ireland to develop this work.

Club Leaders & Volunteers

The Club Development Programme was launched back in November 2024 in partnership with Geoff Wilson consulting. Clubs were tasked with creating strategic plans that focus on developing the areas of Governance, Branding, Technical & Income Generation.

The Nets & Posts scheme was once again provided to the clubs in Q3, 2024. During Round 1, a total of 6 clubs applied and received equipment. Round 2 applications were received in April 2025, and decisions are pending.

Partnerships with Naas, Santry, Dalkey Devils, Balbriggan, Galway, Impact Macroom, and Ballymun Patriot led to the distribution of match balls in lieu of helping deliver the u20 European Championships.

Ireland's Snr Men recorded their first competitive win in 22 years, when they came from 2-down to beat Northern Ireland in the 5-Nations, to take bronze.

Both the Snr and u22 teams had memorable wins over Poland in the Nations Cup.

A young team preparing for the u22 CEV qualifiers were comfortably beaten by Northern Ireland in the St. Patrick's Challenge, 3-0.

Captain Jerry Obiekwe signed for Italian team
Cassano, whilst Lachlann Donnelly & Aiden
Grace secured scholarships to the USA. Peter
McGlynn and Patrick Cawley will play in Slovakia
next season.

The Snr. Men go to San Marino for the Small Countries Association Championship in June, whilst the u22s head to Georgia to face France, Luxembourg and the hosts.

Due to change in the SCA programme the u20 group were left without competition. One competitive match with Northern Ireland ended in a 3:2 defeat.





Senior Women

Head Coach - Mark Delahunty

Ireland's Snr Women recorded two comfortable wins over Northern Ireland in the 5-Nations to take 3rd place after taking sets off Scotland and England earlier in the competition.

The St. Patrick's Challenge match with Northern Ireland was trickier with a young team rallying from behind to win in the tie break.

The Women's team are on home soil for their year's SCA Championships hosting San Marino, Iceland, Scotland and Northern Ireland.

Opposite Emma Byrne won a National League All Star.



u22 Women

Head Coach - Edyta McMullan

The u22 Women are preparing for the CEV qualifiers after being handed a tough draw against European Champions Turkiye, Norway and hosts Spain. The squad had a positive week long camp in Poland to prepare, with local professional clubs talent spotting some youngsters.

The team has been training weekly in Dublin, with weekend sessions each month.

Graham Bell led this age group in last year's European Championship Finals where the squad came up against Italy, Poland, Ukraine, Serbia, Portugal, Finland and Czechia. Whilst each game was lost 3-nil there were numerous positives especially out of system and in defense.







u18 Women

Head Coach - Matt Hanlon

Matt's youngsters (born 2008+) played out a thrilling final match in the SCA Championships, narrowly losing to Northern Ireland 19-17 in the tie break.

The team were severely hampered by injury and availability issues. Earlier in the competition they beat Monaco and just lost out to hosts Malta.

Jaime Tanner and Gabi Smolen had excellent tournaments.

Beach

Head Coach - Melissa Cupples

Youth National teams were active on the sand with Liam Corcoran and Ciagan Davoren winning a key match with Scotland to finish in joint 25th in the u22 European Championships. It was the first time an Irish time had won at that level, and competed in the main draw.

Fiona Lamont and Lara McNichols finished 4th in the SCA Championship in Scotland whilst youth teams competed in the NEVZA Championships and u18s in Madrid gaining valuable experience.

Commission

The HP Commission has been hard at work reviewing the pathway structure and securing additional supports for the programme, including the provision of a Head Athletic Development Coach (Maja Ban) and S&C App that all players can access. BallTime was introduced for video analysis and has been huge success.

A Team Ireland NT weekend was held in Co. Meath for all players.





Sustainable Growth

To continue our participation and performance growth trajectory we must generate new and sustainable revenues that can be invested in the sport.

2024 has been a marquee year in that regard as sponsorship income to support the u20 European Championships has demonstrated there is an appetite for commercial partners to collaborate with Volleyball Ireland.

Searing Point Wealth Management were the main sponsor of the European Championships and the u20 Ireland team, and our sincere thanks go to Patrick Thorpe and his team.

An innovative retail partnership with 'Sleek n Easy' has helped generate new income, point of sale consoles at events have helped sell more shop stock and more commercially minded online campaigns such as 'Black Friday' have also helped grow sales.

Accessible Facilities

A club and community facilities audit was carried out to understand the needs and opportunities within our clubs. Unfortunately, only 6 member club replied. This data is useful to formulate strategic applications to the Government's Sports Capital Fund.

The Net & Post Scheme was re-opened with over 12k of equipment supporting our clubs.

In a historic move, Ireland's first permanent inland Beach Courts were opened in partnership with the Sport Ireland Campus.

Purposeful Impact

Our sustainability agenda was enhanced this season, with the u20 European Championships becoming the first European Volleyball event to use recyclable bottles for players - typically disposable plastic bottles would be mandated. Volleyball Ireland's solution saved the disposal of around 8,000 x 500ml plastic bottles.



Finance Report



Introduction

Volleyball Ireland achieved record growth in 2024, with revenues rising by over €400k to €1.396m, more than double and triple the figures from two and three years ago, respectively. This growth was driven primarily by hosting international events, including the U20 Women's European Championship.

Expenditure increased in line with revenue, resulting in a modest deficit of €21k, up €8k from 2023. This loss, slightly above budget, was due to a change in accounting treatment for staff bonuses, aligning with accrual principles.

Strategic efforts to diversify income have reduced reliance on public funding. Non-public income grew by €500k, including €200k from international team fees, a 20% increase in shop revenue, and €40k in new sponsorships.

Volleyball Ireland also acquired a €32k GerFloor court from CEV/FIVB, adding long-term value to the balance sheet. Cash reserves declined as previously awarded grants were drawn down to support ongoing projects.

Up 40% from €994,719 in 2023 the income increase is largely due to the hosting of major international events, and exceeds €1 Million for the first time.



Corporate Governance



Volleyball Ireland is the Governing body for the sport of Volleyball in the 26 counties of Ireland.

In summary, the organisation's core work is to organise a range of competitions and programmes to grow participation in the sport, leading to an improvement in National team performance in both Volleyball and Beach Volleyball formats of the game.

As the National Federation, we are affiliated to the Confederation de Europeene Volleyball (CEV), Federation de Internationale Volleyball (FIVB), Olympic Federation of Ireland (OFI) and are members of the Federation of Irish Sport, as well as being a Sport Ireland funded body.

Our members are our clubs that compete in the National League.

The Board

The Volleyball Ireland Board has gender balance with a 57:43, Male:Female split of Directors.

Volleyball Ireland were one of the first National Governing Bodies of Sport with gender balance on their Board.

Jordan Donnelly was elected as last year's AGM, as were Gavin Dredge and Elisabeth Rae, who were co-opted to fill casual vacancies before that.

Meetings

The Board met formally seven times since the last AGM, that was held in June 2024, and other ad hoc project specific meetings. Overall, the board had an 98% attendance rate which is up from 88% on last year.

Chief Executive, Gary Stewart handed in his resignation in April 2025 and will serve a 3-month notice period until early July. The CEO reports to the Board and sits in on Board Meetings in a non-voting capacity.

Gary attended 7/8 Board Meetings since the last AGM and was absent when his performance and remuneration package was an agenda item. He did not attend the emergency meeting that was established to discuss his resignation from the role.

Board Member Selection

The Board can be composed of between six and nine Directors, of which two must be Independent and recommended by a Nominations Committee. The Nominations Committee is currently comprised of President Clodagh NicCanna and two non-board or staff members. The Board can co-opt up to two Directors based on a skills gap analysis of the Board. All other Directors are elected by the Membership at an AGM or EGM.

Substantive Board Decisions 2024/25

Since the 2024 AGM the board has made the following substantive decisions:

- Approval of new remuneration package for the CEO and staff
- Approval of various tenders related to hosting the u20 Women's European Championships
- Approved the 2025 budget
- Approved the nomination of Gary Stewart to stand as President of the Small Countries
 Association
- Signed an updated Sport Ireland Governance Code Assurance Statement
- Approved proposals for constitutional change at the upcoming AGM
- Approved the appointment of a recruitment agency to handle the recruitment of a new CEO
- Approved the application to host the Senior Women's SCA Championship and the u19 SCA Beach Championships
- Approval of Elisabeth Rae as Chair of the Audit
 Risk Committee
- Approval of new commercial insurance providers
- Approved player registration fee price increases

Board Member Induction & Training

Volleyball Ireland have developed a robust and in-depth induction programme which includes IvI meetings with staff, Commissions and fellow Directors, as well as formal training from external industry experts on the principals of Good Governance and the Role of a Board Member.

Upon joining the Board all Directors must sign a Letter of Appointment detailing their roles and responsibilities, and take part in a Role of the Board Training session. A calendar of training opportunities is provided related to a skills self-assessment that each Board Member completes. This method will be replicated with Commission members ahead of the new committee cycle.



Board Effectiveness

In late 2023, the Board commission an independent Board Effectiveness Review. Industry expert Adrian McCarthy carried out a comprehensive project that made a number of recommendations, including a reduction in the frequency of Board meetings, more weight placed on the expert Audit & Risk Committee and more in-person meetings.

In summary, the report concluded that Volleyball Ireland (VLY) is a successful and effective Type-B national governing body (NGB) (as defined by Sport Ireland), overseen by accomplished Board members from diverse volleyball and non-volleyball backgrounds.

Compliance Audit

In the Summer of 2023, Volleyball Ireland underwent an external Sport Ireland 'pulse audit', to assess the current levels of governance and financial oversight.

The audit, carried out by KOSI, was positive with Volleyball Ireland found to have substantial compliance with the Governance Code.
Substantial compliance is the 4th highest rating out of 5, and is defined as:

Key controls exist but there may be some inconsistency in application. Compensatory controls are operating effectively. Assurance can be given that the system will achieve its objectives safely.

The Sport Ireland audit recommended that consistency of term lengths is applied for Directors. The Board have proposed adopting this amendment at the 2025 AGM.

The Role of the Board

The Board of Volleyball Ireland meets regularly to provide strategic leadership to the Company, exercise effective control over the organisation, and monitor executive management and performance.

The Board is in a transition from executive to non-executive with several Directors supporting the organisation operationally through the commission structure.

It comprises nominees of the Membership, through election, co-option by the Board and independent Directors. The primary responsibility of all Directors is to always act in the best overall interest of Volleyball Ireland.

Some Board Members will hold portfolios and act as the accountable person for delivery of each Commission and Board Sub-Committee operational plans. Directors can hold multiple portfolios.

Conflict of Interests

The board has a conflict of interest and loyalty policy whereby each Director must declare any potential conflicts of interest and/or loyalty by written statement at the start of each year.

Any board meeting agenda items which may raise a conflict are recorded in the minutes at the start of each Board Meeting. Conflict of Interests 2024-25: Nil.

The Conflict of Interest and Loyalty policy was reviewed and amended in 2023, in line with Sport Ireland Governance Code recommendations.

The next review date is October 2025.



Governance Code

In December 2020, Volleyball Ireland adopted and is compliant with the Sport Ireland Governance Code as a type B organisation. The Code includes the adoption of 64 different actions across five principles of good governance.

The Board completes an annual statement of assurance of compliance with the Sport Ireland Governance Code. In 2024, the only outstanding action was the delivery of a clearer calendar of Board training, as well as the full training of the Company Secretary.

Decision Making

In summary, the Board control and govern the organisation. Strategic powers are distributed to the Commissions or Board Sub-Committees. Where necessary, Commissions may establish sub-committees to oversee competitions or specific tasks.

Staff are assigned to the day-to-day operations of the company, helping and supporting Commissions and Sub-Committees to carry out their functions. In short, the Board through the Commissions set the strategic direction for the company, and staff are tasked with ensuring its delivery.

Anti-Doping

It remains a condition of an adult player's registration to play in the National Leagues that each completes Sport Ireland's anti-doping information module and we remain one of the few NGB's who insist on doing so. No Anti-Doping testing was carried out at any Volleyball Ireland events, or out of competition.

All National team players have completed the FIVB PlayClean online course as well as Sport Ireland's module.

Garda Vetting

Over the last 12 months, VLY successfully processed 178 Garda Vetting applications, this is almost double that of two years ago. The processing time and workload involved in managing GV is increasing, and it's worth noting that other NGBs charge an administrative processing fee.

VLY's Garda Vetting processes have been audited twice, with positive reviews.

Remuneration

Any alterations to employee remuneration is advised by the HR & Remuneration Committee, which is chaired by an Independent expert in this field. Staff salaries are reviewed annually. There is a KPI based bonus available for staff. The Board ratify any decisions in this regard and at the end of 2024 approved new remuneration packages for staff.

Committees and Commissions

As well as sport focussed Commissions (Competitions & Development, Education & Training and High Performance, the Board has established, several Sub-Committees to focus on the business side of the organisation. Like the Commissions, each Committee has a board member representative and supporting staff member.

Following a review by the Board, current subcommittees such as the National League Management Committee, and the Referees Management Committee, will become full Commissions.

A new induction and training programme, as well as a strengthening of our governance arrangement relating to Commissions and Committees will be introduced fully in 2025. This will include term limits, effectiveness surveys and letters of appointment for each Committee. The system will replicate the arrangements for the Board.



Performance Management & Reporting

Volleyball Ireland's Performance Management and Reporting system are aligned with Performance objectives established for staff at the start of the year.

Monthly Activities Reports relate to these objectives. Board Meeting papers are typically circulated 7 days in advance of Board Meetings and include updates from Commissions, staff and Management Accounts.

Each staff member takes part in an annual performance review, with weekly IvIs. The President acts as the line manager to the Chief Executive.

PADACC

The Protests, Appeals, Disciplinary and Complaints Commission was formed in 2022 to give a more consistent and independent approach to handling disciplinary issues. During the season 7 protests were received which is one up similar to last season. One protest was upheld before a Panel was called, and another was rejected.

Three protests were rejected by the independent panel, one of which was taken to appeal, which was then rejected. One protest was upheld. The final protest was not complete and timed out.

Due to the extensive time, both for staff members and volunteers to process and manage the PADACC system, a new pricing system will be applied from August 1st.

PADACC protests will be charged at €150, of which €100 is refundable if the protest is successful. An administrative fee of €50 will be retained by Volleyball Ireland. Any appeal will be charged at €100, which is fully refundable if upheld.

International Representation

In August 2024, Clodagh Nic Canna became the first Irish person elected to the Board of European Volleyball (CEV), where she was chosen as an Executive Vice President.

Later in the year, Gary Stewart was elected as the President of the CEV Small Countries Association, which is a Zonal Association made up of 13 Member Federations.

In December, Board Member Lochlann Walsh was elected as the President of the Olympic Federation of Ireland.

Risk Management

Overview

Audit & Risk Committee

Beth Rae (Chair) Clodagh Nic Canna Gavin Dredge Gary Stewart, CEO Matt Ford, Finance Manager The Audit and Risk Committee held a specific meeting to review the organisation's Risk Register. In total, 26 risks were reviewed, and any with a gross risk rating in excess of +10 are routinely presented to the Board. 5 risks the ARC have identified are listed below.

Risk 1: Performance Pathway

Lack of capacity within VLY staff to ensure a joined up and cohesive pathway for young players to progress in the sport.

Appointment of key staff with a focus on girls, boys, and beach will help to ensure a strong pathway. Appointing a performance & pathways manager should be explored.

Risk 2: Staff & Volunteer Management

Lack of adequately skilled volunteers in key positions may hinder progress. A commissions skills audit should be carried out, with a robust training plan made available to volunteers as well as staff.

Risk 3: Finance

Government funding dries up, due to geopolitical influences out of VLY's control. A commercial strategy should be developed, alongside a review of current fees, with the intention of being less reliant on Sport Ireland support.

Risk 4: Facilities

There is a severe lack of suitable volleyball facilities to meet growth demand. Many clubs have waiting lists or are forced into reduced hours. A facilities audit should be carried out with the view to developing a strategic sports capital application. Clubs should be encouraged to help VLY identify potential facilities.

Risk 5: Safeguarding

Safeguarding and player welfare is always a concern to be monitored. Safeguarding policies and procedures to be regularly updated with the NCO attending some Board Meetings to provide updates.
